



## **Appendix A**

We are not able to determine if the candidate's Campaign Financial Return was prepared in accordance with the requirements of the Nunavut Elections Act and the accounting guidelines issued by Elections Nunavut for the following reasons:

1. We were not able to substantiate that all campaign contributions were utilized for eligible campaign expenditures due to the campaign account statement not being available for inspection.
2. We were not able to substantiate that the surplus reported on the Campaign Financial Return was given to a charitable organization or the Consolidated Revenue Fund due to a lack of supporting documentation.
