If I change my campaign manager during the election, I must submit a Notice to Replace a Campaign Manager which can be obtained from an election officer or found on Elections Nunavut's website;

Optional - If I choose to submit a digital photo, it meets the standards identified in this section. Elections Nunavut uses your photo on our website and on a poster showing who the candidates are.
