If you are qualified to become a candidate and your declaration of candidacy is accepted by the Returning Officer, it will become public record and anyone can look at it.

NOTICE ON WITHDRAWAL
A candidate can only withdraw before 5:00pm local time on the 31 st day before election day by personally submitting a <i>letter of withdrawal</i> to the Returning Officer. This letter must be signed by the candidate <u>and</u> witnessed by two voters of the community who certify they witnessed the candidate sign the letter.


