This annual report covers the activities of the Office of the Chief Electoral Officer for the 2019-2020 fiscal year. It includes the Tununiq by-election, the conduct and administration of the first Nunavut Municipal General Election, municipal by-elections, Alcohol Education Committee elections and by-election, and the Gjoa Haven Liquor Plebiscite.

## Introduction of the Office of the Chief Electoral Officer

The Office of the Chief Electoral Officer (Elections Nunavut) is an independent office of the Legislative Assembly of Nunavut that is overseen by the Chief Electoral Officer. Elections Nunavut is responsible for the administration of territorial and municipal elections and by-elections under the *Nunavut Elections Act*, as well as plebiscites under the *Plebiscite Act*. Under a separate agreement, Elections Nunavut also administers local option liquor plebiscites under the *Liquor Act* for the Department of Finance.

As an independent officer, the Chief Electoral Officer is accountable directly to the Legislative Assembly through the Speaker. This ensures the Office of the Chief Electoral Officer can administer elections and plebiscites in a non-partisan manner; maintaining the integrity of the entire democratic process for all Nunavummiut. The Chief Electoral Officer is appointed by the Commissioner of Nunavut for a 7-year term.

The Management and Services Board provides oversight of the budgetary and human resource requirements of Elections Nunavut. The Chief Electoral Officer is required to report annually to the Legislative Assembly, as well as to report on specific election/plebiscite events. These reports include

recommendations that the Chief Electoral Officer believes will assist in improving the *Nunavut Elections Act* and the election/plebiscite process.

Elections Nunavut provides GIS and mapping support to the Boundaries Commission. The Boundaries Commission is responsible to hold public hearings and propose boundaries and names of constituencies to the Legislative Assembly. The next electoral Boundaries Commission will be conducted in 2022.

Elections Nunavut works with many public and private partners to ensure elections and plebiscites are run as effectively and efficiently as possible. Legal counsel, information technology (IT) support, geographic information system (GIS) upkeep, audit oversight, and electronic voter database management (EVDM) support are all secured through external professional contracts.

The office is located in Rankin Inlet and consists of four permanent employees. The year before and after an event, the casual employees and contract election officers increase the office size to over 190 people.

## **Activities 2019-2020**

## **Tununiq By-Election**

On September 16, 2019, a by-election was held in the constituency of Tununiq to replace the former member Joe Enook. David Qajaakuttuk Qamaniq was elected with 52% of the votes cast. The results of the Tununiq by-election can be found on page 9 of this report.

# 2019 Municipal General Election

On April 1, 2019, the *Local Authorities Elections Act* was repealed and the rules governing municipal elections were harmonized in the *Nunavut Elections Act*.

The Office of the Chief Electoral Officer provided the training and resources to each municipal corporation and District Education Authority to ensure the first municipal general election was administered according to the new rules.

The results of the October 28, 2019 first municipal general election can be found on page 15 of this report.







## Municipal By-Elections

By-elections for mayor were held in Kinngait and Sanirajak, and District Education Authority by-elections were held in Arctic Bay, Clyde River and Qikiqtarjuaq. The results of these by-elections can be found on page 46 of this report.

#### **Alcohol Education Committee Elections**

Elections for members of Alcohol Education Committees in 12 communities were planned for October 28, 2019. Elections took place as scheduled in 3 of these, with acclamations, appointments, and one by-election filling vacant positions in the remaining communities according to various regulations.

The by-election for members of the AEC in Kimmirut was held on December 17, 2019.

# Liquor Plebiscite Gjoa Haven

On December 9, 2019, a liquor plebiscite was held in Gjoa Haven. The results of the plebiscite can be found on page 55 of this report.

## Coordination with Other Agencies

#### **Department of Education**

The Department of Education collaborated with Elections Nunavut to ensure the District Education Authorities were prepared to hold their elections.

The French Education Division of the department provided valuable insight into how past Commission scolaire francophone du Nunavut (CSFN) elections have been supported, and helped distribute information for French-Language Rights-Holders about the upcoming CSFN election through schools, GN offices, and the media.

#### **Department of CGS**

The Department of Community and Government Services collaborated with Elections Nunavut to ensure the municipal corporations were prepared to host their elections.

#### **Department of Finance**

Elections Nunavut administered one liquor plebiscite in Gjoa Haven on behalf of the Department of Finance. The Chief Electoral Officer attended a community forum with staff from Finance prior to the plebiscite.



Elections Nunavut also oversaw the first Alcohol Education Committee (AEC) General Election in conjunction with the municipal elections.

#### **Department of Justice**

Elections Nunavut worked closely with the Department of Justice to ensure local justices of the peace were aware of their important new role in municipal elections recounts.

In addition, staff at corrections facilities in Nunavut (as well as in other jurisdictions) distributed information to Nunavummiut inmates about Special Ballots by mail, and facilitated voting for those who wanted to participate.

#### **Commission scolaire francophone du Nunavut (CSFN)**

Elections Nunavut and the CSFN worked together to inform Nunavut francophones regarding the upcoming CSFN election, and the office provided input in developing a CSFN voters list.

#### **Elections Canada**

The 2019 federal election period, which overlapped with the Nunavut Municipal Elections, provided an opportunity for Elections Nunavut and Elections Canada to combine resources to ensure successful events for both. The agencies shared costs for support staff and resources.

#### **Advisory Committee for Electoral Partners (ACEP)**

The Chief Electoral Officer participates on the Advisory Committee for Electoral Partners. The roundtable discussion between all Federal/Provincial/Territorial Chief Electoral Officers provided an in-person forum for discussion on best practices and information sharing in the field of electoral administration in Canada.

#### Secretariat for Electoral Coordination

The Chief Electoral Officer is a member of the national secretariat advisory committee. The overall mandate of the secretariat is to coordinate the sharing of information and best practices between jurisdictions and provide support for election innovation.

Along with all other electoral management bodies in Canada, Elections Nunavut provides funding for the secretariat.

#### **Canadian Elections Resource Library (CERL)**



Elections Nunavut continues to contribute funds to a shared library hosted by Elections Manitoba. This forum allows Canadian Electoral Management Bodies to

share information and resources in real time.

Along with all other electoral management bodies in Canada, Elections Nunavut provides funding for CERL.

#### CCEO

The Chief Electoral Officer attended the annual Conference of Canadian Election Officials in St. Andrews, NB.

#### **Information and Privacy Commissioner**

The Chief Electoral Officer consulted with Nunavut's Information and Privacy Commissioner on aspects related to privacy in elections.

#### **Canadian Society for Election Official Training (CSEOT)**

Elections Nunavut staff participated in information and privacy training hosted by CSEOT in Ottawa.

### **Vital Statistics- Department of Health**



Vital Statistics provides information to Elections Nunavut regarding those voters who are deceased or who have left the Territory. The

sharing of this information is supported in both the *Vital Statics*Act and through an agreement between the Department of Health and Elections Nunavut.

#### **Nunavut Association of Municipalities**

The Chief Electoral Officer attended the NAM/NAMA AGM and received feedback and suggestions for improvement from the 2019 municipal elections.

The Chief Electoral Officer was invited and attended meetings with municipal councils in Igaluit and Arviat.

## **Provincial Election Visitor Programs**

The Chief Electoral Officer participated in the visitor's program hosted by Elections Alberta during the 2019 Alberta Provincial election. New technology was utilized at the advance poll, including electronic poll books which incorporated voter live strike-off.

#### Planned Activities 2020-2021

## **By-Elections**

Under the *Nunavut Elections Act,* by-elections can be held for MLAs and mayors. Elections Nunavut will be in a constant state of readiness to administer these by-elections.

On February 25, 2020, Simeon Mikkungwak resigned from his role as speaker and MLA. The by-election date was originally set for April 27, 2020. Due to COVID-19, the by-election date was delayed until August 24, 2020.

At the end of March 2020, the member for Kugluktuk, Mila Kamingoak, submitted her resignation. A by-election for the constituency of Kugluktuk will take place in the fall of 2020.

#### **Plebiscites**

Elections Nunavut will be prepared to administer plebiscites under the *Plebiscites Act* and local options liquor plebiscites under the *Liquor Act*.



## Legislative Recommendations

The Office of the Chief Electoral Officer will table recommendations for legislative change informed by previous elections and mentioned in previous annual reports.



# Staff Development

Provide continued opportunities for staff training through the Canadian Society for Election Official Training (CSEOT).

## **Electoral Boundaries Commission Support**

Provide support to the Electoral Boundaries Commission in preparation for the 2022 review.

The OCEO will develop a strategy on improving the level and quality of support to the boundaries commission, including but not limited to the required GIS and mapping support.



## Preparations for the Sixth Nunavut General Election – October 25, 2021


Elections Nunavut will be focussed on the following preparations for the Nunavut General Election to elect Members of the Legislative Assembly on October 25, 2021:

- Ongoing efforts to secure election officers, supplies and voting venues.
- Collaboration with the Department of Health to ensure the safety of candidates and their representatives, election officials, and voters during the election period.
- Ongoing updates to voter and physical address details in the Nunavut Voters List database.
- Outreach to engage new and repeat voters through media, social media, and civic education in high schools.
   All materials used for these purposes are produced inhouse.
- Incorporating new technologies to be used at the polls, including electronic poll books, live strike-off, online voter registration and an online candidate portal.
- Outreach to institutions, businesses, and organizations with post-secondary students, rotational workers, medical travelers and escorts, and inmates to promote awareness of various in-person voting opportunities, and Special Ballot by Mail.

 Updating, producing, ordering, and organizing materials and supplies for distribution to the communities well ahead of election day.

# REPORT ON THE CONDUCT OF THE TUNUNIQ BY-ELECTION

On April 25, 2019, a by-election was announced for the constituency of Tununiq to replace the former Member, the Honourable Joe Enook. The Chief Electoral Officer issued the writ on August 12, 2019 for the by-election to be held on September 16, 2019 in Pond Inlet.

Declarations of candidacy were accepted from David Qajaakuttuk Qamaniq, Charlie Inuarak and Joshua Arreak. Joshua Arreak officially withdrew his candidacy on August 16, 2019, prior to the deadline.

The by-election took place on September 16, 2019, with David Qajaakuttuk Qamaniq being declared elected with 52% of the valid votes cast.

# REPORT ON THE CONDUCT OF THE FIRST NUNAVUT MUNICIPAL GENERAL ELECTION

# Legislative amendments Impacting the 2019 Municipal General Election

On April 1, 2019, the *Local Authorities Elections Act* was repealed. The rules for electing municipal council and District Education Authorities was incorporated into the *Nunavut Elections Act* and administered by the Office of the Chief Electoral Officer.

Section 224.5 of the *Nunavut Elections Act* was amended to permit public servants to stand for election for municipal elections without being required to seek approved leave pursuant to the *Public Service Act*.

## Preparation and Outreach

#### **Election Material**


As this was the first municipal General Election administered by Elections Nunavut, all election material related to previous elections were adapted to fit the new rules. This included developing plain language guides and forms to be used by candidates throughout the election periods.

#### **Ballots**

New ballot templates were designed to combine Mayor and Council contests on one ballot when possible.

Since this was the first-time multiple contests would be found on one ballot, the municipal corporations and DEAs were engaged to ensure the new ballots would be easily understood by their communities.

Instructions for Special Ballots by mail were updated so voters using that option would understand the new ballots clearly when marking their choices.





#### **Internal Processes**

Processes and forms were modified to accommodate multiple vacancies being filled in Hamlet Council, DEA, and Alcohol Education Committee elections, rather than a single position elected in MLA elections.

In addition, the number of elections taking place on election day would potentially triple the required poll staff, ballot boxes, and supplies typically used in past MLA elections, but the need for these resources was reduced substantially with the new combined ballots.

The Judicial Recount process, in place for general elections, was adapted in collaboration with legal counsel and the Department of Justice for use in Justice of the Peace Recounts. This satisfies requirements set out in the new municipal elections section of the *Nunavut Elections Act*.

#### **Training**

Although the municipal corporations and District Education Authorities were required to secure election officers and voting venues, Elections Nunavut provided support by offering in-person training to every Returning Officer in Nunavut. These training sessions were held over 2 days in each of the three regions, and ensured that election officers were aware of the new rules to be used. Originally, the training was to be held remotely relying on email and videoconferencing, however in-person training

was requested by municipal corporations and District Education Authorities, since it was identified as a more robust and reliable means of developing capable Returning Officers. This was especially relevant as many of the Returning Officers had administered multiple elections in the past under the *Local Authorities Elections Act*, and many of the new rules found in the *Nunavut Elections Act* differed significantly from their previous experiences.

#### **Joint Agreements**

Elections Nunavut developed a joint agreement template for use by the municipal corporations and District Education Authorities if they wished to hold their respective elections jointly. This permitted the cost-sharing of human resources and voting venues. Most of the communities opted to hold their elections jointly, and this proved to be the most effective and efficient means of administering their municipal elections.

#### **Name Change Plebiscites**

A few communities requested to hold their own plebiscites on changing their community's name at the same time as the municipal elections. Although these plebiscites were not administered by Elections Nunavut under the *Plebiscite Act*, Elections Nunavut entered into agreements with these communities to share information and resources to assist them with their vote.

#### Outreach

Elections Nunavut participated in various local and territorial radio call-in shows and provided details on the municipal elections to the media. The Chief Electoral Officer attended AGMs hosted by the Coalition of Nunavut District Education Authorities (CNDEAs), Nunavut Association of Municipalities (NAM), and participated in preparatory meetings with the commission scolaire francophone du Nunavut.

At the request of the municipal council of Arviat, the Chief Electoral Officer attended a special meeting to answer questions and clarify various aspects of their election.

Contact was made with many organizations and businesses within and outside of Nunavut to inform students, medical patients and escorts, and rotational workers who might be away from home during the election period about ways to vote — including Special Ballot by mail.



### Municipal Election Day- October 28, 2019

Blowing snow and limited visibility did not prevent staff from getting to the Elections Nunavut office on Municipal Election Day, but there were disruptions to voting in some communities in the Kivallig Region.

The Chief Electoral Officer issued directions for elections in Rankin Inlet and Chesterfield Inlet to be postponed until the following day. Although Whale Cove and Baker Lake polls opened on schedule, voting had to be suspended on Election Day to be resumed the following day.

Work at the Elections Nunavut office had to be adjusted later in the day when a downed power-line affected the office for several hours. A portable generator was sourced, and set-up outside with extension cords through the window to power essential computers and the internet connection. As daylight faded, the staff supplemented emergency lighting in the office with headlamps and flashlights until the power was restored.

Elections Nunavut plans to purchase a portable generator that will provide sufficient power to mitigate situations of this nature in the future.

Administrative recounts were automatically required in 20 election contests to meet legislative requirements- when results between elected and non-elected candidates in any election were less than 2% of the total number of valid votes. Most of these were completed before the end of the day, however a small number were deferred to the following day.

Candidates in Pond Inlet and Kugluktuk applied for a recount under section 224.18(2) of the Act. The Returning Officer in these communities conducted the recounts under direction from the Chief Electoral Officer.

Naujaat recount results for municipal council led to a tie-vote, which was resolved the following day when the candidates involved agreed to a draw by the returning officer.

Igaluit election results required an automatic administrative recount, which continued into a second day after Election Day because of the large number of votes that had to be recounted.

## **ELECTIONS AND PLEBISCITES UNDER THE LIQUOR ACT**

### **Alcohol Education Committee Elections**

In August 2019, the *Liquor Plebiscites and Elections Regulations* was enacted. These regulations defined the leadership role of the Chief Electoral Officer in Alcohol Education Committee Elections and Liquor plebiscites.

Elections Nunavut engaged the municipal corporations in the 12 communities that had Alcohol Education Committees (AEC), and commenced arrangements to hold AEC elections concurrent with the municipal elections. Although voter and candidate eligibility criteria matched the other types of municipal elections, regulations between the communities differed in the number of positions on the committees, and in some cases, the rules around filling vacant positions.

- Three communities conducted elections since they had more candidates than positions.
- Six elections were acclaimed, as there were fewer candidates than vacant positions for their committees.
- Two elections had no candidates declared during the candidacy period, but their regulations allowed positions to be filled by appointment.
- The AEC in Kimmirut had one candidate acclaimed, but their regulations required a byelection to fill vacant positions. Kimmirut's byelection was held on December 17, 2019.

### Gjoa Haven Liquor Plebiscite

Elections Nunavut conducts liquor plebiscites on behalf of the Department of Finance. This local option liquor plebiscite was administered according to the *Liquor Act* and was initiated by a petition of voters in Gjoa Haven. To effect a change, at least 60% of the total valid votes cast must be in favour of the proposed rules.

On December 9, 2019, residents of Gjoa Haven voted on the following question,

"Are you in favour of replacing the current prohibition system in the Hamlet of Gjoa Haven and surrounding area with a restricted quantities system? In addition to the general liquor laws of Nunavut, the restricted quantities system would limit the amount of liquor that a person can purchase in or import into the community every 14 days to:

- a) one (1) litre of spirits;
- b) four (4) litres of wine; and
- c) eleven (11) litres of beer."

Since the 60% in favour of YES threshold was not met, the liquor prohibition will continue in Gjoa Haven.

### Legislative Recommendations

### **Notices Placed in Newspapers**

The *Nunavut Elections Act* requires the publication of certain notices in newspapers in Nunavut. With the increased use of social media and other forms of online communication platforms within our communities, the need for notices to be published in printed form is less relevant than in previous times. It is costly to advertise in print-form. The funds from this costsaving measure can be redirected to other forms of more effective public engagement.

The Chief Electoral Officer recommends that the Legislative Assembly of Nunavut amend the provisions requiring the publishing of certain notices in newspapers, and permit the publishing of prescribed information on the internet website and social media sites of Elections Nunavut.

### **Voting Times Across Nunavut**

In 2004 the *Nunavut Elections Act* was amended to standardise voting times for all constituencies across Nunavut so that MLA elections results would be available at the same time across Nunavut's time-zones. Section 104 sets the hours of polling stations to central standard time (9am to 7pm). It is not equitable for voters in the west to have voting times from 8am to 6pm to coincide with the time prescribed in the *Act*. Section

224.16(2) sets the hours of polling stations for municipal elections to local time.

The Chief Electoral Officer recommends that the Legislative Assembly of Nunavut amend the provision relating to voting times for MLA elections and by-elections so that local time is used for polling station hours.

# Campaign Contributions - Exceptions to Maximum Contributions

The *Nunavut Elections Act* says that, subject to specific exceptions, the maximum election contribution an individual, corporation, association or organization may make to a candidate cannot exceed \$2,500 in total during an election period (section 168(5)). Currently the cost of transportation services is exempted from this maximum amount. This is to reflect the high cost of transportation services in the Territory.

The Chief Electoral Officer recommends that the Legislative Assembly of Nunavut amend the provision relating to the exception to the maximum contribution to also exempt accommodation services.

### **Campaign Contributions - Advertising on Social Media**

The *Nunavut Elections Act* requires the cost of advertising be considered a contribution to a candidate's campaign. The Act should be updated to reflect the use of social media in campaigns.

The Chief Electoral Officer recommends that the Legislative Assembly of Nunavut amend the provision relating to advertising contributions to include the cost of advertising through social media.

#### **Disclosure of Voter Names**

The Chief Electoral Officer recommends repealing the provision requiring a returning officer to disclose to candidates the names of individuals who voted in the advance poll. The Chief Electoral Officer is concerned that the provision does not adequately protect the privacy of voters, especially in constituencies who have low numbers of voters during advance polls.

# Supplementary Legislative Recommendations – Municipal General Elections:

On April 1<sup>st</sup>, 2019, the *Local Authorities Election Act* was repealed. At the same time, the *Nunavut Elections Act* was amended as new provisions were enacted to guide district education authority (DEA) and municipal council elections. The

*Nunavut Elections Act* no longer deals exclusively with the elections of members of the Legislative Assembly. This change in purpose should be reflected in section 1 "Main Purpose", and section 3 "Application" the *Nunavut Elections Act*.

The Chief Electoral Officer recommends that the Legislative Assembly of Nunavut amend the following sections:

- 1. (1) The purpose of this Act is to establish a regime for the election of members of the Legislative Assembly, municipal councils, and district education authorities that promotes the meaningful exercise of the democratic rights and freedoms of the residents of Nunavut and the equality of opportunity to participate in determining the outcome of elections and the formation of government.
- **3.** (1) This Act applies to the election of members to the Legislative Assembly, <u>municipal councils</u>, and <u>district</u> education authorities.

### **Vacancies**

If the office of mayor, councillor or member of a district education authority becomes vacant, the municipal council or DEA are required to fill the vacancy, but the *Nunavut Elections Act* does not specify when this should concur. For greater certainty, the Chief Electoral Officer recommends that the Legislative Assembly of Nunavut amend the provision relating to filing of vacancies to say that vacancies should be filled as soon as reasonably practicable.

If the municipal council or DEA do not appoint the candidate from the previous election who was not elected to that office but had the highest number of votes from among the unelected candidates, a public request for applications for appointment is made. There is however no prescribed and standard form for that process.

The Chief Electoral Officer recommends that the Legislative Assembly of Nunavut amend the provision relating to filing of vacancies to say that where a public request for applicants is made, the application must in the approved form. This will ensure consistency and transparency across the communities.

Finally, under the *Act*, the Chief Electoral Officer is to designate **one day** each year for the holding of by-elections needed to fill vacancies for mayors in that year (ss. 224.10(8)). Depending on when a vacancy arises, this provision could leave a community without a mayor for up to a year.

The Chief Electoral Officer recommends that the Legislative Assembly of Nunavut amend this section to provide greater flexibility and allow the Chief Electoral Officer to determine an appropriate day for the holding of any by-elections needed to fill a vacancy for mayor.

#### **Automatic Administrative Recounts**

Currently, the *Nunavut Elections Act* requires the returning officer to conduct a recount if the difference between the number of votes in favour of two or more candidates for the

same municipal office is nil or less than 2% of the total number of votes.

The Act does not specify that only valid votes are to be counted for the purposes of determining whether a recount is required. In addition, because of the way voting is conducted in the context of municipal elections, a recount is automatically triggered in the majority of cases for councillor and DEA elections. It is recommended that a minimum number of votes, not the percentage, trigger an automatic administrative recount.

The Act also says that if there is a difference of 25 votes or less a candidate may, within 10 days of the result, apply to the Returning Officer for a recount. This timeline is problematic as Returning Officers are only appointed until the results are final. Absent an automatic recount, the results will be deemed final well before the 10-day period. If a candidate challenges the results after they are final, there may not be a returning officer in the community.

The Chief Electoral Officer recommends that the Legislative Assembly of Nunavut amend the provisions relating to administrative recounts to trigger a recount only if the number of votes between two candidates – for the last vacancy for office – is less than 5 votes. The Chief Electoral Officer also recommends reducing the time a candidate can request a recount to 4 days from the declaration of the result, and state that the application be made to the Chief Electoral Officer.

**224.18.** (1) The returning officer shall conduct a recount under this section if

- (a) the difference between the number of votes in favour of two or more candidates for the same office is <u>less</u> than 5 votes in the election for that office; and
- (b) the recount is needed to determine the successful candidate for mayor or for the last vacancy for office as a councillor or a member of a district education authority.

### Application for recount

(2) If there is a difference of 25 votes or less between the number of votes cast for a candidate declared elected and a candidate who was not elected, a candidate who was not declared elected may, within 4 days after the declaration of the result, apply to the Chief Electoral Officer for a recount under this section.

# Additional Amendments – Covid-19 Related Considerations:

A General Election is the single largest event held in Nunavut, where the interaction of candidates, voters, and election officers is encouraged and at times legislated.

It is imperative that the Chief Electoral Officer considers the impacts of a worsening pandemic situation and prepares for variables not yet known.

The *Act* provides the Chief Electoral Officer with the authority to adapt any provision in response to a mistake, emergency, disaster, or unusual or unforeseen circumstance. However, there are certain provisions in the *Act* that may not fully consider the impacts of a Nunavut-wide pandemic. By amending these provisions, the Office of the Chief Electoral Officer would ensure the election laws take into the account the impacts of a pandemic on candidates, voters and election officers.

### **Special Ballot Provisions**

The Chief Electoral Officer notes that if it were necessary to run an election with mail-in ballots only because of covid-related concerns, it will be necessary to have greater flexibility to extend the time to receive those ballots. If there are any unexpected delays attributed to weather, the closure of Canada Post outlets due to staffing or transportation carrier issues, ballots may not be delivered on time. If there is no flexibility to respond to unforeseen and unusual circumstances, a significant number of valid votes cast may not be counted.

For this reason, the Chief Electoral Officer should be given the power to extend the period to receive a special ballot. Currently the *Act* specifically removes this option from the Chief Electoral Officer's power to adapt the provisions of the *Act* during unusual situations in order to achieve the purpose of the *Act*.

The Chief Electoral Officer also recommends an amendment to section 100 so that a voter may obtain a special ballot from

either the office of the Returning Officer or the Chief Electoral Officer.

### Withdrawal of the Writ

The Chief Electoral Officer is aware of the real and perceived risks involved with administering an election during a pandemic. The evolving nature of orders received from the Chief Public Health Officer will have a direct impact on the ability of election officers to administer a safe, transparent and fair election.

The *Act* takes into consideration delaying municipal elections if the Chief Electoral Officer believes it is impractical to hold the election because of extreme weather, an emergency or other similar event.

The *Plebiscites Act* delegates the authority to the Chief Electoral Officer to withdraw a writ if the Chief Electoral Officer is of the opinion that it is impractical to hold the plebiscite because of a disaster or similar event.

The Chief Electoral Officer recommends that the Legislative Assembly amend section 41 to permit the Chief Electoral Officer to certify to the Commissioner in Executive Council that they believe the pandemic, or other similar disaster, puts or may put the health or safety of persons in a constituency at risk.

## Appendix A- Adaptations of the Nunavut Elections Act for the Tununiq By-Election

# Form of Deposit Required - Authority under Section 190 of the *Act*

On August 14, 2019, the Chief Electoral Officer directed the Returning Officer for the constituency of Tununiq to accept the \$200 deposit from prospective candidates in a form other than those listed in Subsection 74(2) of the *Nunavut Elections Act*.

The purpose of this direction was to address the lack of cheque-making services available in Pond Inlet during the declaration period.

# Delay of Voting in the Office of the Returning Officer - Authority under Section 190 of the *Act*

On September 2, 2019, the Chief Electoral Officer directed the Returning Officer to delay voting in the Office of the Returning Officer for one day.

The direction was issued because of delays in the arrival of voting material. The delay was attributed to mechanical issues experienced by the common airline carrier.



## Appendix C - Adaptations of the Nunavut Elections Act for the Municipal General Election

### Prospective Candidate's Declaration of Indebtedness to the Municipal Corporation - Authority under subsection 224.12(4) of the *Act*

On September 12, 2019, the Chief Electoral Officer issued directions to all prospective candidates to submit a completed declaration of indebtedness to the municipal corporation form.

The purpose of this direction was to ensure prospective candidates verified their eligibility under subsection 224.5(2)(g) of the *Act*.



# Delegated Authority to Accept Declarations – Authority under Sections 215(1)(a); s 224.3, s.71 of the *Act*

On September 23, 2019, the Chief Electoral Officer directed that Returning Officer delegate the power to accept declarations of candidacy to Chief/Senior Administrative Officers.

The purpose of the direction was to allow declarations of candidacy to continue to be accepted in the event the Returning Officer was unable to, or had declared a conflict of interest.

# Mobile Poll Date Change – Authority under Section 224.16 of the *Act*

At the request of the Returning Officers for Kugluktuk, Cambridge Bay and Iqaluit, the Chief Electoral Officer permitted the mobile poll to be held on a date other than October 21, 2019.



The purpose of this was to ensure election officer could focus their election effort on the advance vote throughout the entire day on October 21, 2019.

## Advance Poll Location- Authority under Section 224.16 of the *Act*

At the request of the Returning Officers for Baker Lake and Arviat, the Chief Electoral Officer permitted a polling station to be opened at an airport for one day during the advance voting period. The purpose of this was to facilitate the voting by rotational mine workers- who would have otherwise been unable to vote.

# Postponement of Election Day – Authority under Section 224.8(5) of the *Act*

On October 28, 2019, the Chief Electoral Officer directed that the Returning Officers in Rankin Inlet, Whale Cove, Baker Lake and Chesterfield Inlet delay their election day.

The purpose of this direction was in response to the inclement weather that made holding the election on October 28, 2019 impractical and unsafe.

## Appendix D – Municipal Elections: Summary of Complaints, Investigations and Prosecutions

# **Concerns from Candidates – Formal Investigation** *Not Requested*

The following are concerns raised by candidates during the municipal election period, but formal complaints were not submitted to the RCMP for investigation:

- The period of time legislated in Section 77(1) of the *Nunavut Elections Act* for a candidate to withdraw was too short;
- The changing of local voting venues;
- Certain advance poll locations as requested by the Returning Officer and authorized by the Chief Electoral Officer;
- That incumbent candidates held their position of authority throughout the election period;

- The role of RCMP in investigating complaints; and
- The rules surrounding the placement and removal of campaign material on election day.

### Complaints from Candidates- Formal Investigation Requested

There were no formal complaints submitted to the RCMP.

### **Investigations and Prosecutions**

There were no reported investigations or prosecutions for the 2019 Municipal General Election.
