### District Education Authority By-Election Results – December 9, 2019

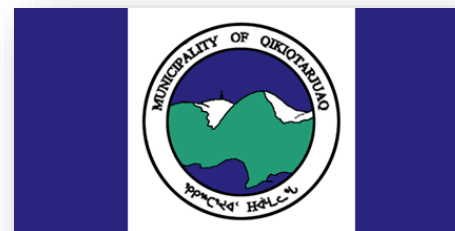

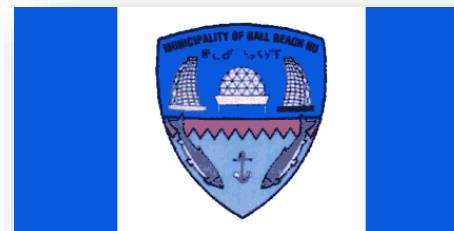
