If you don't send a completed financial return before the deadline, you may be charged under the Nunavut Elections Act and you will not be able to be a candidate in any territorial, municipal council or district education authority election for 5 years.

Anonymous Financial (\$\$\$) Contributions

This is money that came from people that you do not know who they were.

- ✓ You can only receive a maximum of \$1,000 per anonymous contribution. If it is more than \$1,000, you must either find out who gave it to you and return it, or send it to the Chief Electoral Officer.
- ✓ The total combined limit for all anonymous contributions is \$2,500. Any amount over \$2,500 must be returned to the contributor or sent to the Chief Electoral Officer.

Goods & Services Contributions
