Appendix A

We are not able to determine if the candidate's Campaign Financial Return was prepared in accordance with the requirements of the Nunavut Elections Act and the accounting guidelines issued by Elections Nunavut for the following reasons:

1. The Campaign Financial Return was not completed in full.
2. We were not able to substantiate that all campaign contributions were utilized for eligible campaign expenditures due to the campaign account statement not being available for inspection.
3. The financial agent did not return the contribution receipts to the Chief Electoral Officer.
4. We were not able to substantiate campaign expenditures of \$200 due to supporting documentation not being available for inspection.

Goods & Services Contributions




