

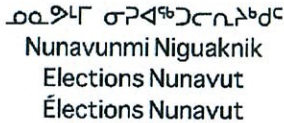

Appendix A

We are not able to determine if the candidate's Campaign Financial Return was prepared in accordance with the requirements of the Nunavut Elections Act and the accounting guidelines issued by Elections Nunavut for the following reasons:

1. We were not able to substantiate campaign contributions and expenditures due to the campaign account statement not being available for inspection.
2. We were not able to substantiate campaign contributions due to the unused contribution receipts not being available for inspection.
3. The Candidate and Financial Agent signed the statutory declaration after the post election period.

Goods & Services Contributions
