Date: October 3, 2017

Due to unforeseen circumstances, there is a delay in the issuance of Voter Information Cards (VICs) in the community of Cambridge Bay.

Last week, vandalism occurred at the Office of the Returning Officer in the community of Cambridge Bay and a reported theft of postage stamps required for the sending of VICs in accordance with s. 56(1) of the *Nunavut Elections Act*.

Under section 190 of the *Nunavut Elections Act* the Chief Electoral Officer (CEO) may adapt any provision of this *Act* to achieve the purposes of this *Act* where it appears to the CEO during an election period that, because of any mistake, emergency, disaster or unusual or unforeseen circumstance, the *Act* does not accord with the urgent needs of the situation.

This Direction is necessary and appropriate to preserve the integrity of the electoral process in Nunavut.

- 1. The RO shall send a Voter Information Card (VIC) to every voter who is included on the voter list for the community of Cambridge Bay as soon as possible but no later than Thursday, October 5, 2017.

Instructions on Campaign Material (Print and Text) (s. 186(4) *Nunavut Elections Act*)

To: All Election Officials in Nunavut All Declared Candidates in Nunavut All Financial Agents in Nunavut All Campaign Managers

Date: October 3, 2017

These Instructions are being issued to resolve potential uncertainty with respect to s. 186 of the *Nunavut Elections Act* in relation to the size of the print or text of information on campaign material.

Subsection 186 requires campaign material to include information on the person campaigning and the individual responsible for the campaign material. This information must be communicated in a way that is as easy to read, hear or see as the majority of the substance of the message being communicated by the campaign material.

Under subsection 186(4) of the *Nunavut Elections Act* the Chief Electoral Officer may issue instructions respecting the communication and inclusion of information required by section 186.

These Instructions are necessary and appropriate to preserve the integrity of the electoral process in Nunavut.

The Chief Electoral Officer, pursuant to subsection 186(4) hereby issues the following Instructions:

- 1. Candidates and election officials are expected to use common sense when applying the rule that the information required by section 186 must be communicated in a way that is as easy to read, hear or see as the majority of the substance of the message being communicated by the campaign material.
- 2. The purpose of the rule is to prevent the use of anonymous campaign material or campaign material that obscures, or makes it difficult, to identify the source of the material.

- 3. For print or text campaign material, the information should be in a font size no smaller than the smallest font size on the campaign material.
- 4. If the campaign material consists of very large text (e.g. a campaign sign) the information may be in a smaller font than the other text, as long as it complies with subsection 186(2), namely that it is as easy to read and see as the main message of the sign.
- 5. Small buttons and campaign stickers are exempt from the requirements set-out in section 186(1)(b).
- 6. These Instructions are subject to further Instructions that may be issued as circumstances may require.
