INSTRUCTIONS TO CANDIDATES AND REPRESENTATIVES						

- 1. Fill out both sides of this form and sign it. You will agree to follow the laws for candidates and their representatives at the poll. Each candidate can have only one person at a time at a polling station. The person can be the candidate or a representative, but not both.
- **2.** Give this signed form to the deputy returning officer (DRO) as soon as you get to the polling station, and swear/affirm the oath before the DRO.

Candidates/representatives CAN:

- ✓ Watch the DRO fold and initial ballots;
- ✓ Look at election documents;
- ✓ Watch people vote from a distance;
- Take information from the polling record or register and voters list;
- ✓ Watch the DRO sort or count ballots after the poll closes;
- ✓ Notify the Returning Officer if you think the election officers did something wrong; and
- Get a copy of the Statement of the Poll (official results will also be provided to the candidate).

Polling Place:

Any building used for voting.

Polling Station:

The location(s) within the polling place where voting takes place.

Candidates/representatives CAN NOT:

- Enter or re-enter the polling place once the polls have closed;
- Communicate with anyone outside of the polling place;
- Have more than one person at a polling station at a time;
- Turn on or use a cell phone, camera, recorder, or any other electronic equipment in the polling place;
- Campaign, greet or otherwise engage voters, or try to influence them in any way;
- Disturb election officers, or get in their way;
- Have any campaign material at the polling station (i.e. buttons);
- Go inside homes or other places people live when they vote with the Mobile Poll;
- Mark anyone's ballot in any way;
- * Hang around outside the polling place; and
- ➤ Touch any voting materials.
