

Appendix A

We are not able to determine if the candidate's Campaign Financial Return was prepared in accordance with the requirements of the Nunavut Elections Act and the accounting guidelines issued by Elections Nunavut for the following reasons:

1. We were not able to substantiate campaign contributions of \$250.00 due to supporting documentation not being available for inspection.
2. Ineligible tax receipts of \$1,884.85 were not returned to Elections Nunavut and made available for inspection.
3. Ineligible expenses of \$200.00 were claimed on Campaign Financial Return and the Return not revised.
4. We were not able to substantiate that all campaign contributions were utilized for eligible campaign expenditures due to the campaign account statement not being available for inspection.
5. Candidate and financial agent did not sign representation letter.
